**Media Advisory:
Trade Association Committee formed to strengthen role of Trade
Associations in Industry Transformation**

On 2 February 2017, a new Trade Association Committee (TACOM) convened its kick-off meeting at SCCC.

TACOM was set up by SCCC as a business-led platform to identify and solve challenges faced by trade associations, so that trade associations can play a stronger leadership role in transforming and growing our local industries. With SCCC and twenty other TAs moving into the new Trade Association Hub in Jurong Town Hall later this year, the objective of TACOM is to look at how to strengthen the “software” of our TAs and build stronger collaboration. To achieve this, TACOM will focus on three main strategic areas – (1) building Trade Association capabilities; (2) fostering collaboration and new partnerships, and (3) serving as an advocacy and feedback channel to Government.

The inaugural TACOM comprises Presidents or appointed representatives from 13 trade associations and chambers across various sectors for a two-year term. The current member composition is found in Annex A. TACOM is chaired by SCCC President, Mr Thomas Chua, with Senior Minister of State for Ministry of Trade & Industry and Ministry of Culture, Community and Youth Ms Sim Ann as its Advisor.

At the kick-off meeting, TACOM discussed the challenges faced by trade associations and identified four areas that the Committee can work on, with the support of Government agencies. These four areas are:

- (a) Strengthen professionalism and capabilities of trade associations. This includes the need to attract talent to consider association management as a career; improving the governance and management of trade associations; and encouraging the sharing of expertise and resources among associations.

- (b) Develop industry standards and certification framework. This will guide trade associations on how to implement an industry standards and certification programme to uplift the professionalism of local trades.
- (c) Stronger role of trade associations in Vocational Training. Engage local institutes of higher learning to involve trade associations to co-lead in the curriculum development and conduct of vocational training, to ensure better match of skills with the needs of industry.
- (d) Greater flexibility in Government Grants. To encourage trade associations to tap on government funding to embark on more industry upgrading programmes.

Working groups will be formed under TACOM to study the four areas in greater detail and implement solutions and projects. These working groups will carry out further consultations with other trade associations, and will be supported by Government agencies.

“TACOM will be an action-oriented committee that will solve real issues faced by our trade associations. We are happy that the Committee has received the strong endorsement and support of the Government, and look forward to working hand-in-hand with Government agencies to deliver concrete outcomes that will benefit the business community,” said SCCC President Mr Thomas Chua.

“This is an excellent initiative by SCCC and the founding members of the TACOM. Trade Associations and Chambers are our key partners in driving industry transformation. To do so effectively, our TACs need to continually strengthen their capabilities in order to provide greater leadership and value to their members. Many good ideas were discussed at the kick-off meeting, and I look forward to closer collaboration between the TACs and Government agencies in identifying best practices and project opportunities, and overcoming common challenges together,” said Senior Minister of State Sim Ann.

Besides TACOM representatives, the kick-off meeting was also attended by Government officials from the Ministry of Trade and Industry, SPRING Singapore, International Enterprise Singapore and JTC Corporation.
